  - Newark Housing Authority Funding for landlords that are interested in rehabbing their properties and renting to individuals with Section 8.
  - OASAS (Older Adults Safe and Sound) provides repairs/modifications to homeowners to reduce the risk of falls. They serve Wayne, Ontario and Seneca with this program.
  - Apartments for Success and Success Center Currently Full
  - Soldier On Funding available to assist Veterans who are at risk of homelessness.
  - Wayne County Planning Comprehensive Housing Study has been completed. Release expected soon.

- 5. Strategic Planning for Consortium
  - a. Jen discussed working to develop a strategic plan for the Consortium. Discussed possibly having a separate work group to work towards this.
  - b. Jen also discussed HUD requirements, including lived Experience/DEI/Board Representation and homeless advisory committee. CoC is currently meeting these requirements; however, strategic planning is needed in order to ensure that we continue to grow.
- 6. Housing Grant Updates
  - a. Emergency Rental Assistance Program (ERAP)
    - Portal closed on January 20, 2023. OTDA continues to review applications submitted through November 30, 2022. If more funding becomes available, applications submitted after November 30 will be reviewed.
  - b. Landlord Rental Assistance Program (LRAP)
    - Portal closed on November 21, 2022. The only applications that are being processed are those for property owners that own buildings with 20 units or more.
  - c. Emergency Solutions Grant (ESG) CV No-Cost Extension
    - No-cost extension has been filed. FLACRA has nearly exhausted funding in all four countie Ontario, Seneca, Wayne, and Yates. Ontario County agencies with funding still available include Family Promise, Catholic Charities, and LawNY. Seneca County agencies with funding still available includes LawNY, Yates County agencies with funding still available include, Keuka Housing Council, and LawNY. Wayne County – LawNY
